

#### **EXECUTIVE SUMMARY**

In the first quarter of 2025, the Indian Ocean Rim Association (IORA), actively participated in regional initiatives, dialogues, and worked to strengthen cooperation across priority areas with different stakeholders.

IORA Day 2025 was held on 7 March to mark the Association's 28th anniversary, in Mauritius. The event was honoured by Honourable Hambyrajen Narsinghen, Junior Minister of Foreign Affairs, Regional Integration and International Trade of Mauritius, and members of the diplomatic corps.

IORA participated in the 8th Indian Ocean Conference, held in Muscat, Oman from 16-17 February 2025. The conference focused on the theme "Voyages to New Horizons of Maritime Partnership" and IORA Secretary-General, H.E. Mr. Sanjiv Ranjan, participated in the high-level plenary session, sharing insights on evolving maritime cooperation in the 21st century.

The Secretariat played an active role in various initiatives and technical meetings aimed at advancing regional cooperation and development. Among various activities, some include:

- Regional Legal Conference on Combating Illegal Fishing;
- 32nd Indian Ocean Rim Business Forum (IORBF) Meeting;

The Indian Ocean Rim Association (IORA) marked its 28th anniversary on March 7, 2025, celebrating nearly three decades of fostering regional cooperation and sustainable development across the Indian Ocean.

To mark this day, a commemorative event was held at the Caudan Arts Centre in Port Louis, bringing together dignitaries, diplomats, and stakeholders to reaffirm the commitment to regional cooperation and sustainable development. The event was graced by the presence of Honourable Hambyrajen Narsinghen, Junior Minister of Foreign Affairs, Regional Integration and International Trade of Mauritius, along with members of the diplomatic corps.

He highlighted the organization's role in advancing economic growth, maritime security, and environmental sustainability among its 23 Member States and 12 Dialogue Partners.

IORA Day serves as a platform to celebrate the association's milestones and reaffirm its mission of enhancing trade, maritime safety and security, investment, tourism, academic, science and technological cooperation and people-to-people connectivity in the region.





## IORA Secretary-General Participates in 8th Indian Ocean Conference, Oman



The 8th Indian Ocean Conference, organised by the India Foundation in collaboration with the Ministry of Foreign Affairs of Oman, was held from 16 to 17 February 2025 in Muscat. The conference brought together regional leaders, policymakers, and experts to discuss pressing issues shaping the Indian Ocean region. This year's theme, "Voyages to New Horizons of Maritime Partnership," reflects a shared vision for strengthening maritime cooperation, security, and connectivity across the region.



H.E. Mr. Sanjiv Ranjan, Secretary-General of the Indian Ocean Rim Association (IORA), participated in the plenary session titled "Navigating New Frontiers: Evolving Maritime Landscape in the 21st Century." ## IORA Participates in Regional Legal Conference on Combating Illegal Fishing



The IORA Secretariat participated in the Regional Legal Conference on Addressing Illegal Fishing in South Asia, held from 17 to 19 March 2025 in Colombo, Sri Lanka. The conference was organised under the United Nations Office on Drugs and Crime (UNODC) Global Maritime Crime Programme (GMCP), in collaboration with the Bay of Bengal Programme Inter-Governmental Organisation (BOBP-IGO) and other regional partners.

The high-level event brought together 19 key stakeholders from Bangladesh, Maldives, and Sri Lanka to deliberate on the pressing issue of illegal, unreported, and unregulated (IUU) fishing in the South Asian region.

Discussions at the conference centred on legal prosecution, interdiction strategies, and the importance of regional collaboration and cooperation in addressing maritime crimes. The participation of IORA underscored the organisation's continued commitment to promoting sustainable fisheries management and enhancing maritime security across the Indian Ocean region.

## IORA Secretary-General Meets UNODC Delegation to Strengthen Cooperation on Maritime Security



The delegation from UNODC (United Nations Office on Drugs and Crime) comprising of Ms. Ashita Mittal, Regional Representative for Eastern Africa (ROEA), Ms. Maria Temesvari, Deputy Regional Representative for Eastern Africa (ROEA), Ms. Siji Song, Regional Programme Coordinator-Eastern Indian Ocean and Dr. Shafina Aishath, Senior Programme Support Officer had meeting with the H.E Mr Sanjiv Ranjan, the Secretary-General of IORA on 20th January 2025. The delegation had discussion with the Secretary-General and officials of IORA on issues of maritime security, combating transnational crimes, and promoting sustainable development in the Indian Ocean region. The UNODC expressed to synergise the collaboration with IORA on various priority areas in the Indian Ocean Region.


#### 32nd Indian Ocean Rim Business Forum Meeting

The 32nd meeting of the Indian Ocean Rim Business Forum (IORBF) was held virtually on 20 January 2025, bringing together key business and government representatives from across the Indian Ocean region.

Chaired by Mr. Buwaneka Perera, Secretary General of The Ceylon Chamber of Commerce, Sri Lanka, the meeting gathered 36 participants from twelve IORA Member States—Bangladesh, India, Indonesia, Iran, Malaysia, Mauritius, Mozambique, Oman, South Africa, Sri Lanka, Thailand, and the United Arab Emirates—alongside representatives from Dialogue Partners Russia and Türkiye.

The meeting focused on advancing business-to-business and business-to-government cooperation to unlock trade and investment opportunities within the region. A major highlight was the development of an annual IORBF calendar of activities aimed at fostering sustained economic collaboration among participating countries.

The IORBF continues to play a vital role in strengthening regional economic integration and promoting private sector engagement across the Indian Ocean Rim.

## IORA-AFD Workshop in Bangkok: Advancing Innovation and Investment to Tackle Marine Debris in the Indian Ocean



IIORA and Agence Française de Développement (AFD), with the support of Department of Marine and Coastal Resources of the Kingdom of Thailand held a regional workshop on Promoting Scientific Research, Innovation and Investment Opportunities for Sustainable Marine Debris Management in the Indian Ocean in Bangkok, Thailand from 24-26 March 2025.

The event supported the implementation of the IORA Strategic Framework of Action on Marine Debris and the Work Plan of the Working Group on the Blue Economy.

Experts from the IORA Member States and the Indo-Pacific gathered to exchange knowledge and explore science-based, innovative, and financially sustainable approaches to tackling marine debris such as the initiative of Plastic Odyssey. The workshop featured discussions on scientific research, innovative technologies, economic impacts, and financing mechanisms. A site visit provided practical insights into local marine debris management efforts, with the support of Ocean Clean Up and Eco Marine.

#### Outcomes:

- Enhanced understanding of marine debris issues and the role of science and monitoring
- Identification of viable and innovative waste recovery models
- Recognition of economic costs and sustainable financing options
- Strengthened regional collaboration and exchange of best practices

This initiative reaffirmed IORA's commitment to promoting a cleaner, more resilient Indian Ocean through science, innovation, and investment.

#### 4th Working group meeting on Blue Economy



The 4th Working Group Meeting on the Blue Economy was held virtually on 30 January 2025 under the chairship of Mr. T.B.H. Witjaksono Adji, Director for Asia-Pacific and African Intra- and Inter-Regional Cooperation (Indonesia), and Mrs. Paramita Tripathi, Joint Secretary (Oceania and Indo-Pacific) (India). Member States and Dialogue Partners shared updates on the progress made in implementing the WGBE Work Plan and presented new project proposals. The Chairs underscored the importance of continuing efforts to achieve the Sustainable Development Goals (SDG 14), advance the IORA Strategic Framework on Marine Debris, and combat Illegal, Unreported, and Unregulated Fishing.

#### IORA Secretariat Participates in Innovation Island Summit to Promote Sustainable Blue Economy

The IORA Secretariat participated in the Innovation Island Summit, a global platform dedicated to advancing sustainable solutions for island and coastal communities.

The Observer Research Foundation (ORF), in collaboration with the Indian High Commission in Colombo and the Capital Maharaja Group (CMG), co-hosted the Innovation Island Summit on 20-21 February, 2025 in Colombo, Sri Lanka.

The summit brought together policymakers, private sector leaders, experts from international organizations, and representatives from development banks to explore innovative strategies for resilience, economic growth, and environmental sustainability.

Major themes for deliberation included the potential framework of a post-2030 development agenda, connectivity and infrastructure, finance and investment, emerging technologies, the blue economy, energy and green priorities, as well as the role of women and youth as agents of change. Through these discussions, the Summit sought to foster a deeper spirit of collaboration among stakeholders from various regions and sectors.

As part of its commitment to fostering a sustainable Blue Economy, IORA highlighted the critical role of regional cooperation in driving progress. The Secretariat emphasized the importance of sharing best practices and leveraging digital innovation to enhance marine resource management, strengthen coastal economies, and promote sustainable ocean-based industries.

## Webinar on "Shared experiences through the Early Career Ocean Professional Programme (ECOP) program"



The IORA Blue Carbon Hub hosted the Webinar on "Shared experiences through the ECOP program" on 3 March 2025. The aim of the Webinar was to increase the awareness of ECOP Program and to enable ECOPs to share their experiences, the benefits of the program and their achievements. The webinar also enabled participants to enquire on the application and selection process, as well as discuss tips on a successful application.

## Unlocking the Value of Blue Resources in Africa and the Indian Ocean: Insights from the UNECA Blue Economy Valuation Toolkit

As part of the implementation of the Memorandum of Understanding between IORA and UNECA, more specifically to collaborate on research and capacity building on the Blue Economy, IORA and UNECA co-hosted a webinar on 5 March 2025, titled "Unlocking the Value of Blue Resources in Africa and the Indian Ocean: Insights from the UNECA Blue Economy Valuation Toolkit (BEVTK). The Webinar aimed to introduce the BEVTK, demonstrate its application, and promote its adoption for evidence-based policymaking across Africa and the Indian Ocean region.

Over 100 participants from 43 countries joined the two-hour virtual event, with strong representation from EAC and IORA Member States, with more modest participation from ECCAS countries. Women accounted for 45% of speakers and approximately 54% of participants, reflecting a balanced and inclusive discussion. Across presentations and audience interventions, there were severalrecommendations to strengthen the Blue Economy in Africa and the Indian Ocean byimproving governance, investment, security, data reliability, and regionalcollaboration, ensuring sustainable and inclusive growth.

### IORA Secretariat Engages with Russian Delegation to Tackle Marine Pollution



IORA Secretariat held fruitful discussions with a visiting Russian delegation, including representatives from the Institute Macromolecular Compounds, as part of ongoing efforts to address environmental challenges, particularly marine pollution caused microplastics. This served as a platform to explore future research opportunities and joint projects aimed at combatting microplastics in the ocean. They underlined the urgency of the issue and the importance of collaborative scientific efforts to find sustainable solutions. Key topics discussed: sharing research findings to strengthen cooperation in academic research, science, and technology.

The inaugural advisory meeting set the stage for strategic discussions on future activities and engagement plans that will further strengthen the support system for emerging professionals in the region.

Delegates from 12 of IORA Member States and 1 Dialogue Partners, namely India, Indonesia, Iran, Madagascar, Malaysia, Maldives, Mauritius, Oman, Seychelles, South Africa, Tanzania, Thailand and Germany participated in the event.
